

5	Severe muscular dystrophy cases and accident victims	1.Sadarem Certificate with Minium 85 % of Disability 2.Certificate from medical board consisting of Neurology, Neurosurgery and Orthopedics, Certifying the patient Condition as bedridden/Confined to wheel Chair	15000
6	ART (PLHIV)	6 months continuous treatment in ART (Anti Retroviral Therapy) Centre.	4000
7	Severe Haemophilia (<2% of factor 8 or 9)	1.Medical Certificate must be issued by the Medical Board Constitued for the purpose(Medical College/District Hospital/Area Hospital of their District) 2.Required Lab reports suggesting the disease need to be furnished signed by Asst.Prof,Pathology	10000
8	Kidney, liver and heart transplant	1.Apart of the certificate issued by the Medical Board constituted for the purpose(Medical College/District Hospital/Are Hospital of their District) 2.Complete discharge summary issued by the hospital mentioning the surgical procedure	10000
9	CKDU Private	No age limit. Every month Dialysis treatment taken at Private Hospitals	10000
10	CKD Serum creatinine of >5mg	1.Apart of the certificate issued by the Medical Board constituted for the purpose(Medical College/District Hospital/Are Hospital of their District) 2.Report of serum creatinine from Govt Labs>5mg/dl Consostently on two separate occasion with atleast 3 months gap,with lab reports signed by Asst Prof,Biochemistry.	10000
11	CKDU GOVT	No age limit. Every month Dialysis treatment taken at Government	10000
12	Bilateral Elephantiasis-Grade 4	1.Application must be forwarded through D.M.O to the Medical Board 2.The Medical Board of Medical college/District Hospital/Area Hospital has to certify giving detailed description of disease condition duly mentioning the grade of disease disability	10000
13	CKD Small contracted kidney	1.Apart of the certificate issued by the Medical Board constituted for the purpose(Medical College/District Hospital/Are Hospital of their District) 2.The following USG findings of kidney are Mandatory" a)U/L or B/L small contracted kidney b)Size,Shape,Architecture of kidney	10000
14	Multideformity leprosy	Application must be forwarded through D.L.O to the DMHO with detailed description of the disease along with visible deformity photograph	6000
15	CKD Estimated GFR <15 ml	1.Apart of the certificate issued by the Medical Board constituted for the purpose(Medical College/District Hospital/Are Hospital of their District) 2.Report of CKD stage 3,4&5 as per KIDGO Guidelines with estimated GFR values <15ml/min	10000
